<ul style="list-style-type: none"> <li>➤ Should a player(s)/ pair(s) ranked 1-32 from any country withdraws from the tournament, the particular entry (place) will be given to the next highest-ranked player/ pair from the same country as long as the Eligibility Quota is not exceeded; as stipulated in <b>Eligibility</b>.</li> </ul>												
<ul style="list-style-type: none"> <li>➤ After the completion of Phase 2 Eligibility Process, should the entries not reach the maximum entry quota as specified in (Event Entries), Badminton Asia has the right to select the next highest players/pairs to be eligible, so long as the <b>maximum entry quota of the player/pair's members does not exceed 4 in that particular event</b>.</li> </ul>												
<ul style="list-style-type: none"> <li>➤ Priority of nomination will be given according to the player's individual or pair with higher BWF World rankings.</li> </ul>												
<ul style="list-style-type: none"> <li>➤ If the Players/ Pairs are granted protected ranking by BWF, protected ranking points will be used in place of their original ranking points.</li> </ul>												
<ul style="list-style-type: none"> <li>➤ For Singles, only players that are ranked in the BWF Asia players during the Eligibility Date are eligible to participate in the championships.</li> </ul>												

- For Doubles, only players playing as pairs and ranked in the BWF Asia players world ranking list would be eligible. Notional/ adjusted ranking of pairs will not be considered.
- In each event, Badminton Asia shall be entitled to nominate one wild card entry per event so long it does not exceed the maximum entry quota as specified in (Event Entries).
- It's not mandatory for Badminton Asia to exercise its right to nominate a wild card entry in any or all events.
- Any wild card nominated by Badminton Asia must not exceed the maximum entry of four (4) in each event for a given member association, and the wild card entries must have the approval of the member association of the player/ pair concerned.
- If Badminton Asia does not exercise their wild cards, the next highest-ranking player/pair in the BWF world ranking would be eligible to enter unless the total exceeds the “**Eligibility**” and/ or the “**Maximum Entry Quota**” stated above.

<b>Rights</b>	<ul style="list-style-type: none"> <li>➤ Badminton Asia reserves the right to make the final decision for the nomination of players.</li> <li>➤ Badminton Asia Championships will be run in accordance with, but not limited to, the Badminton World Federation (BWF) General Competition Regulations (GCR) and Regulations stipulated in this prospectus. In the event of any dispute, the decision of the Badminton Asia Events Committee will be final.</li> </ul>
<b>Format of Play</b>	<ul style="list-style-type: none"> <li>➤ All Events of the Main Draw will be played on a knock-out basis after the qualification on a league basis.</li> <li>➤ BWF Standard Rally point system of 3 games x 21 points will be used as the scoring system.</li> <li>➤ Service Height Measuring Device will be used in this Championship.</li> </ul>
<b>Responsibility &amp; Penalties</b>	<p>Every Member Association participating in the Badminton Asia Championships shall be responsible for all expenses incurred by its players and officials, including travel, hotel accommodation, and other expenses.</p> <p><b>Withdrawal Penalty</b></p> <ol style="list-style-type: none"> <li>1. It is compulsory for the top ten (10) Asian-ranking players/pairs eligible to play in the tournament. (Men’s Singles, Women’s Singles, Men’s Doubles, Women’s Doubles, and Mixed Doubles).</li> <li>2. If any top ten (10) Asian ranking player/ pair withdraws from the tournament for any reason whatsoever, the player/pair Member Association shall be penalized an administrative fine of USD5,000.</li> <li>3. Exemption from the administrative fine (in Item 2 above) will be considered by Badminton Asia on receipt of an official Representation along with a Medical Certificate. The said player/ pair would be required to attend the tournament for a minimum of two (2) days and must take part in any media, activity, and/ or function arrangements by Badminton Asia and/ or the host organizer during that time. Badminton Asia holds the right to waive this obligation if Badminton Asia is satisfied that medical conditions prevent such travel.</li> <li>4. For doubles events (Men’s, Women’s, and Mixed), the exemption from the administrative fine (in Item 2 above) will be considered by Badminton Asia if the players are no longer playing as a pair, and this <b>MUST</b> be communicated in writing to Badminton Asia before the <b><i>Deadline Confirmation by Members on Entries from Eligibility (Phase 1)</i></b> The players concerned SHALL NOT play as a pair in any BWF/ Badminton Asia Sanctioned tournament for the next (6) months after the Badminton Asia Championships. Failing this, Badminton Asia will impose an administrative fine of USD5,000.00 on the Members Association concerned for falsification of information.</li> <li>5. If a medal-winning player/ pair of the Member Association is not present at the medal ceremony for any reason whatsoever, the Member Association shall be penalized by an administrative fine of USD 1,500.00 per player/ pair.</li> </ol>

	<p>6. If a Member Association fails to show up at the Championships (No Show) for any reason whatsoever, the Member Association shall automatically be penalized with an administrative fine of USD 5,000.00 per member association.</p> <p>7. If a team of a Member Association arrives late or departs early for any reason whatsoever and affects the team's ability to play or complete their scheduled matches or ties, such Member Association shall be penalized by an administrative fine of USD 1,500.00 per member association.</p>
<b>Substitution</b>	<ul style="list-style-type: none"> <li>➤ A player/pair may participate in an event of the Badminton Asia Championships only if the player's / pair's entry is made by the date/ confirmation as stated in the "Timeline."</li> <li>➤ From the Final dateline confirmation by Member Association on Eligible Entries (Phase 2) until the Sunday prior to the draw date, a player/pair who has entered may be unable to take part due to illness, injury, or other unavoidable cause that the player's/pair's place in singles and/or doubles will be taken by the next eligible player/pair as per Regulations for Badminton Asia Championships.</li> <li>➤ No changes or substitutions of any kind can be made after the Monday prior to the draw date and also to the Draw after it has been made except corrections as in BWF Regulations or promotions as in Regulation in General Competition Regulations.</li> <li>➤ The Referee may re-draw a particular qualifying draw if it has been rendered severely imbalanced and if play in that Draw has not begun.</li> </ul>

<b>Competition Rules &amp; Regulation</b>	Relevant Badminton World Federation, BWF Major Event's Tournament Regulations, and Badminton Asia Regulations shall be applicable to this competition.
<b>Clothing &amp; Advertising</b>	<p>Clothing and advertising will be permitted in accordance with the competition regulations of the Badminton World Federation. (<b>GCR 20 - 24</b>)</p> <p>The player's name on the back of clothing shall be identical to the name registered as the LAST NAME (or an abbreviation thereof) in the BWF Player database. The LAST NAME is defined as the family name, surname, or similar name under the respective naming protocol of the Member count. (<b>GCR 23.3</b>)</p> <p><b><u>MANDATORY CLOTHING REGULATIONS</u></b></p> <ol style="list-style-type: none"> <li>1. The name of the player and the Country is MANDATORY from the first day of the event.</li> <li>2. In doubles, each player in a given pair must wear shirts and shorts (or equivalent articles of clothing) of the same color and similar design throughout a match.</li> <li>3. Failing to attend the meeting is liable to be fined as per BWF Statutes. Member Associations can request someone to represent them at the meeting as long as the Referee knows it is acceptable in advance.</i></p>
