Once a male player submit his entry in under 13 Men's Singles, he will not be eligible to play in Men's Singles in any other age group.)” Players must be members of Associations affiliated to the BWF and in good standing. <p>*Under 19* All players must be under 19 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2007. The minimum age for all players shall be 12 years old, i.e. born on or before 31st December 2012.</p> <p>*Under 17* All players must be under 17 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2009. The minimum age for all players shall be 12 years old, i.e. born on or before 31st December 2012.</p> <p>*Under 15* All players must be under 15 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2011. The minimum age for all players shall be 10 years old, i.e. born on or before 31st December 2014.</p> <p>*Under 13* All players must be under 13 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2013. <p>Clothing & Advertising</p>	<p>Clothing and advertising will be permitted in accordance with the competition regulations of Badminton World Federation. (GCR 20 - 24)</p> <p>The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count. (GCR 23.3)</p> <p><u>MANDATORY CLOTHING REGULATIONS</u></p> <ol style="list-style-type: none"> 1. Name of the player is MANDATORY from the first day of the event. 2. From First day onwards, doubles partners must wear clothing of the same colour. 3. From First day onwards, opposing players must wear clothing of significantly different colours.
<p>On Court Doctor</p>	<p>On Court Doctor will be on duty throughout the competition at the tournament venue.</p>
<p>Doping Control</p>	<p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body. <p>Badminton Integrity</p>	<p>Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.</p> <p>To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.</p>
