**Constitution of
Ties and Teams
(Mixed Team
Championships)**

Constitution for Mixed Team Championship (New Team Relay Format)

The Each Tie of the Mixed Team Championship shall comprise of ten (10) x Eleven (11) Points format:

- Two Men's Singles
- Two Women's Singles
- Two Men's Doubles
- Two Women's Doubles
- Two Mixed Doubles

The Winner of the Team tie will be the **team first to reach hundred and ten (110) points.**

- **First Match**
 - o The first match will play one (1) game to 11 points
 - o Change of court end at 6 points
- **Second Match**
 - o The second match will start at the score of the first match and continue from the score, however in a way where the losing player/pair of the first match will have achieved a minimum of 5 points or the actual number of points reached whatever is more.
 - o The second match will play until one of the players/pairs reach 22 points
 - o Change of court end when reaching 17 Points.
- **Third Match**
 - o The third match will start at the score of the second match and continue from that score, however in a way where the losing player/pair of the second match will have achieved a minimum of 10 points or the actual number of points reached whatever is more.
 - o The third match will play until one of the players/pairs reach 33 points.
 - o Change of court end when reaching 28 Points.
- **Fourth Match**
 - o The fourth match will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the third match will have achieved a minimum of 15 points or the actual number of points reached whatever is more.
 - o The fourth match will play until one of the players/pairs reach 44 points.
 - o Change of court end when reaching 39 Points.
- **Fifth Match**
 - o The fifth match will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the fourth match will have achieved a minimum of 20 points or the actual number of points reached whatever is more.
 - o The fifth match will play until one of the players/pairs reach 55 points.
 - o Change of court end when reaching 50 Points.
- **Sixth Match**
 - o The sixth match will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the fifth match will have achieved a minimum of 25 points or the actual number of points reached whatever is more.
 - o The sixth match will play until one of the players/pairs reach 66 points.
 - o Change of court end when reaching 61 Points.
- **Seventh Match**
 - o The seventh match will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the sixth match will have achieved a minimum of 30 points or the actual number of points reached whatever is more.
 - o The seventh match will play until one of the players/pairs reach 77 points.

- Change of court end when reaching 72 Points.
- **Eight Match**
 - The eight matches will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the seventh match will have achieved a minimum of 35 points or the actual number of points reached whatever is more.
 - The eight matches will play until one of the players/pairs reach 88 points.
 - Change of court end when reaching 83 Points.
- **Ninth Match**
 - The ninth matches will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the eighth match will have achieved a minimum of 40 points or the actual number of points reached whatever is more.
 - The ninth matches will play until one of the players/pairs reach 99 points.
 - Change of court end when reaching 94 Points.
- **Tenth Match**
 - The eight matches will start at the score of the third match and continue from that score, however in a way where the losing player/pair of the ninth match will have achieved a minimum of 45 points or the actual number of points reached whatever is more.
 - The eight matches will play until one of the players/pairs reach 110 points.
 - Change of court end when reaching 105 Points.

Important Note

- No player shall play in more than four (4) matches. A player can play one, two, three or four matches in a tie.

- In case the same player is playing Two (2) Consecutive matches, he/she shall not be allowed any additional rest.

The size of the team shall be as per **Entry Nomination for (Mixed Team Championships)**

- If, as a result of injury or illness sustained after arrival at the venue, a team has only one male or one female player, that player may play in only four matches, and the remaining matches involving that player's gender shall be conceded to the opposite side.
- If, for the above reasons, the team is reduced to two players only, either both of the same gender or one of each gender, the whole tie shall be conceded.

Format

Mixed Team Championship (League Format)

The Mixed Team Championship shall be played in two stages:-

- a) **Group Stage (Qualifying Stage):** Round Robin within groups.
- b) **Knockout Stage (Final Stage):** Top Two (2) teams from each group will advance to the knockout stage in Quarter Finals, Semi-finals and finals.

Draw of the knockout stage will be made after the completion of the last match of the Group Stage.

Teams from the same group shall not be drawn to meet in the first round in the knockout stage.

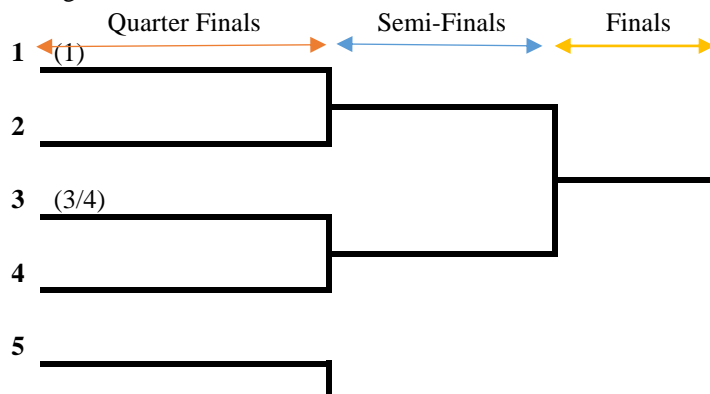

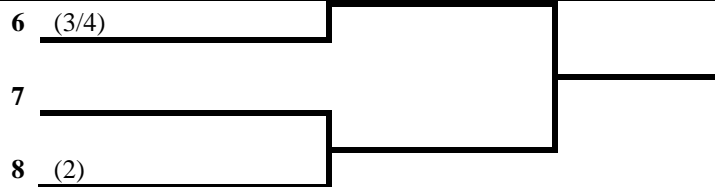

Methodology of the Group Stage Draw

- 1. If there are a total of 12 Teams, they will be drawn into 4 Groups (Group A, Group B, Group C, and Group D)
- 2. Draws shall be conducted by Badminton Asia.
- 3. The top 2 ranked teams shall be dealt with as follows:
 - No. 1 placed at the top of Group A
 - No. 2 placed at the top of Group D
- 4. The other ranked teams shall be dealt with as follows:
 - No. 3 and No. 4 will be drawn by lot at the top of Group B and C
 - No. 5 to 8 will be drawn by lot at the second position of the groups
 - No. 9 to 12 will be drawn by lot at the third position of the groups.

Knock Out Stage Draw's Methodology

The Teams will be dealt with as follows:

- I. Seeds 1 and 2 will be placed in Positions 1 and 8
- II. Seeds 3 and 4 will be drawn into Positions 3 and 6
- III. The remaining teams will be drawn into Positions 2, 4, 5, and 7 accordingly.
- IV. Teams from the same group will not be drawn to play in the First Round (Quarter Finals) in the knockout draw.

* The teams from the same group shall not be drawn to meet in the first round in the knockout stage.

* Seeding for the Knock Out stage will be determine based on the seeding ranking and the final position of the Group Stage

Individual Championships

The Individual Championships shall be played in Full Knock Out Format will be used in all Individual Events using 3 x 21 Point Scoring System

Important Note:

- a) Badminton Asia reserves the right to determine the number of groups and the size of each group for the Group Stage to be decided based on the number of participating teams.
- b) Badminton Asia reserves the right to determine the size of the draw for the Knockout Stage accordingly based on the number of participating teams.
- c) Badminton Asia reserves the right to determine the size of the draw for the Individual Championships accordingly based on the number of participating teams.
- d) Badminton Asia reserves the right for final decision for any matter related to the Championship.

Seeding

Seeding will be done by Badminton Asia based on BWF World Junior rankings. The date of the world ranking to be used will be in accordance with the dates stipulated in the **Key Dates** section.

Total Ranking Points of each event will be calculated based on the highest **BWF Junior Ranked** from the top player/s of One Men's Singles, One Women's Singles, Two Men's Doubles, Two Women's Doubles, and Two Mixed Doubles (One Men, One Women) from each member association, and seeding will be calculated by comparing the total ranking points of each member to determine the overall strength of the team. An example of a Seeding Chart is given below:

In cases where there are rankings that are unavailable, the ranking points will be taken as zero.

Order of Play (New)

Team Managers will submit their team composition **no later than three (3) hours before the start of each tie.**

Before the team tie starts, a draw will be made between the Team Managers who will choose the first match to be played.

- The first five matches of the tie must contest one of each discipline (i.e. MS, WS, MD, WD, XD)
- The **winner** of the draw will choose the **first and third matches.**
- The **opposing team** will choose the **second and fourth matches.**
- The **match not having chosen will be played fifth.**
- The last five matches (matches six to ten) shall follow the **same order** as the first to five matches determined as per above.

Visa Application

As of the end of 2023, the Indonesian Government has issued a new type of VISA engaging in sports, music and art related activities. For the sports relation named Sports Visa. In this case, all participants (players, officials, technical officials, etc.) entering Indonesia to participate in the International Tournament must apply for this type of Visa in advance.

Another update from the government, as of the end of April 2024, the Sports Visa can only be applied by the guarantor, in this case, PBSI. In order us to proceed the visa application please fill up your data in the Visa Form and complete it along with the following required documents by **Friday, 20th June 2025** to hospitality@pbsi.id & staffhubln.pppbsi@gmail.com by completing the following documents:

- Color scan of passport (validity for 6 months at least)
- Color Photograph
- Flight Ticket with your name stated on it

Visa Sport Fee is USD 250/person.
