4. All entries **MUST** only be submitted through your Member Associations.

After the closing date, the BWF Online Entry System will send a notification to all participating Member Associations confirming receipt of final entries. The Member Associations should contact BWF immediately if such notice is not received by the Wednesday (the next day of the entries closing date) by noon BWF Headquarters time (+08.00h GMT) following close of entries.
