Competition Rules & Regulation	Relevant Badminton World Federation Regulations shall be applicable to this competition. Seed Withdrawal Movement will be implemented in this tournament. You may refer to BWF STATUTES General Competition Regulation 11.3
Clothing & Advertising	Clothing and advertising will be permitted in accordance with the competition regulations of the Badminton World Federation. (GCR 20 - 24) The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname, or similar name under the respective naming protocol of the Member country. (GCR 23.3) In cases where colors of clothing clash on TV Court, The referee/umpire may request that the players change their clothing to a different color, The player with the lower ranking, in accordance with the M&Q Report will be asked to change. MANDATORY CLOTHING REGULATIONS 1. Name of the player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of the same colour. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colours.
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament venue.
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor and, if necessary, get a Therapeutic Use Exemption (TUE).
