Badminton Asia has the right to reject entries of any Member Associations, if entry is considered against the interest of the Championships and/or contains a condition unresolved by the entry deadline. 6. Badminton Asia has the right to reject entries of any Member Associations, if it violates BWF STATUTES GCR 6: International Representations For members who are having technical difficulties, kindly contact Ms. Belle at belleng@badmintonasia.org before the entry deadline provided above.

	After the closing date, the BWF Online Entry System will send notification to all participating Member Associations confirming receipt of final entries.
